SUPPORTING DEPOSITION
GENERAL

Defendant

Todd J. Gaddy, residing at 55 Main St. Apt b. Mount Morris Ny 14510, by this Supporting Deposition, makes the following allegations of fact in connection with an accusatory instrument filed, or to be filed, with this Court against the above named defendant(s):

I have known Shaun Theriault for two or three years. Shaun has been to my house several times. I have gone hunting with Shaun several times, gun and bow hunting for deer. We usually hunted on Shauns uncles property off of Tallman Rd in Mount Morris. I asked Shaun how he can hunt since he has been arrested for felonies. Shaun said I don't know I just go to Walmart and buy my license. Shaun always carries the same shotgun when we hunt.

Shaun came to my house to hide the gun sometime in during the first couple weeks of December 2003. I can not remember the exact date but I am positive when Shaun told me that he hid the gun it was a week day. The reason I remember this is because Shaun came to Mark's pizzeria at around 7:00 pm and I only work in the evenings during the week. The gun Shaun carries is a Remington 870 with a rifled barrel. The gun has also been customized by Shaun. Shaun sanded down the stock and made engraving on the underside of the rear stock. The engraving is like a tribal design, like a tattoo. The rear stock has a high gloss finish because he re finished it with stain after he sanded it. I could easily identify the gun if I saw it.

Shaun came into Marks Pizza where I work and told me that he broke into my house and hid his gun in my house. I was really angry at Shaun I told him to get the gun out of my house. I told Shaun I don't want to get into trouble for you. I knew that Shaun was a felon and should not have a gun. Shaun said he would get it out of my house but he had something to do now.

When I went upstairs later that night I saw the gun in my livingroom. The gun was partially wrapped in a towel. I could tell it was the same shotgun he always carries when we hunted together.

Shaun Theriault came to my house the next day. Shaun came up the back stairs. Shaun and I were on the back balcony talking. I asked Shaun, did you hear about this stuff in Geneseo. Shaun said hey Todd I did a job in Geneseo. Shaun said "that was me" in Geneseo. Shaun said he robbed some college students in Geneseo. Shaun said that they kids had stolen from him so he was going to get his money back. Shaun said he went to a house over there and took care of business. Shaun said don't tell anyone that it was me that did the job on the news. I gave Shaun his gun back and he left with his gun. The gun he left with is the same gun that I described earlier with the customized stock.

The foregoing factual allegations are based upon personal knowledge of the deponent (and upon information and belief, the sources of deponent's information and belief being, personal knowledge).
